





ZADOW IN VOLUME 1289, PAGE 748 OF THE OFFICIAL PUBLIC RECORDS OF LLANO COUNTY, TEXAS, SAID 36.000 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS DESCRIPTION AS FOLLOWS:

**BEGINNING** at a 30d nail found at the northeast corner of said 125.00 acre tract and a northwest corner of a called 100 acre tract conveyed to Johnizo Cain in Volume 127, Page 232 of the Deed Records of Llano County, Texas along the south line of a called 320.50 acre tract conveyed to Itz Family, LP in Volume 1509, Page 42 of the Official Public Records of Llano County, Texas, for the northeast corner hereof;

**THENCE** South 19°00'02" West, along the east line of said 125.00 acre tract and the west line of said Cain tract, generally along a fence, at a distance of 2259.11' pass a 10" pine fence post on the north side of Llano County Road No. 309, and continuing across said County Road, for a total distance of 2397.30' to a 8" pine fence post at a northeast corner of a called 526.4 acre tract conveyed to Mabel Barton Cain in Volume 127, Page 224 of the Deed Records of Llano County, Texas, at the southeast corner of said 125.00 acre tract and hereof;

THENCE North 86°53'26" West, along the south line of said 125.00 acre tract and hereof and the north line of said 526.4 acre tract, generally along a fence a distance of 430.47' to a ½" iron pin set south of said County Road, whence a 60d nail found in the base of a 14" live oak tree bears North 86°53'26" West 267.08';

THENCE North 05°08'07" East, crossing said 125.00 acre tract along an unfenced line, at a distance of 53.68' pass a 60d nail set north of said County Road, at a distance of 1768.60' pass a 60d nail set on the north side of Hickory Creek, for a total distance of 1959.73' to a ½" iron pin set along the north line of said 125.00 acre tract and the south line of a called 7.86 acre tract conveyed to Itz Family, LP in Volume 1509, Page 42 of the Official Public Records of Llano County, Texas, for the northwest corner hereof, whence a ½" iron pin found at a 30" live oak tree bears South 78°02'52" West, a distance of 147.82'

**THENCE** along the south of said 7.86 acre tract and the north line of said 125.00 acre tract and hereof, generally along a fence, the following courses and distances:

- 1) North 78°02'52" East, a distance of 92.29' to a ½" iron pin found;
- 2) North 39°23'35" East, a distance of 302.95' to a 36" live oak tree;
- 3) North 62°02'22" East, a distance of 29.72' to a 32" live oak;
- 4) North 77°02'00" East, a distance of 64.18' to a ½" iron pin found at a 8" hackberry tree on the west side of said Hickory Creek at the east corner of said 7.86 acre tract in the south line of said 320.50 acre tract;

**THENCE** continuing along the north line of said 125.00 acre tract and hereof and the south line of said 320.50 acre tract, generally along a fence, the following courses and distances:

- 1) South 89°52'06" East, crossing said creek a distance of 510.06' to a 30d nail found at a 15" live oak tree;
- 2) North 85°52'24" East, a distance of 153.92' to the **Point of Beginning**, containing 36.000 acres, more or less.
